Application for a label amendment dated February 26, 1999

On February 26, 1999, you submitted an application to amend the subject label. Revisions are made to:

Add the word "containerized" to the front panel statement to read "Sprinkle in any containerized standing water including water gardens."

Add the word "containerized" to two statements in the General Information section to read "When spread over the surface of containerized water..." and "MOSQUITO BITS may be used in all types of containerized standing water..."

Add the word "containerized" to a statement under the subheading "Outdoor Use Around the Household" in the Directions for Use section to read "...over the surface of the containerized standing water found around the home."

Delete the phrase "And any other location near the household where water collects and remains for a period of time" under the subheading "Apply to Standing Water Near the House Such As:" in the Directions for Use section.

The labeling amendments referred to above under the Federal Insecticide, Fungicide, and Rodenticide Act as amended are acceptable, subject to the following comments:

- 1) The front panel statement "Sprinkle in any containerized standing water including water gardens" is phrased as a direction for use. The word "Sprinkle" should be replaced with "For use" or a similar, non-directive term.
- 2) Under the Ingredient Statement add the sentence "There is no direct relationship between intended activity (potency) and the percent active ingredient by weight."
