Do not wet articles to point of run-off or drip and do not water the treated area to the point of run-off.

Remove or cover dishes, utensils, food processing equipment, and food preparation surfaces, or wash them before use. Remove or cover exposed food and drinking water before application. Do not allow adults, children, or pets to enter the treated area until sprays have dried. Not for broadcast use on indoor residential surfaces.

- 6. Applications to vertical surfaces directly above pervious surfaces, such as soil, lawn, turf, mulch or other vegetation) only if the pervious surface does not drain into ditches, storm drains, gutters, or surface waters.

Spot treatments must not exceed two square feet in size (for example, 2 ft. by 1 ft. or 4 ft. by 0.5 ft.).

For soil or foliar applications, do not apply by ground within 25 feet of lakes, reservoirs, rivers, permanent streams, marshes or natural ponds, estuaries and commercial fish farm ponds.

especially in cracks and crevices, and hidden areas around sinks and storage areas, behind baseboards, around doors and windows, behind and under refrigerators, cabinets, sinks, stoves, the underside of shelves, drawers, bookcases, and areas where they occur.

**CARPENTER ANTS:** For effective control, locate and treat nests and surrounding areas. Apply until damp around doors and windows and other places where ants enter premises and where they crawl and hide. Spray into infested wood through existing openings.

**BROWN DOG TICKS and FLEAS** in buildings: Apply until damp in infested areas including pet beds and resting quarters, nearby cracks and crevices, under the edges of rugs and floor coverings, between and under cushions of upholstered furniture and other areas where these pest occur. Old bedding of pets should be removed and replaced with fresh bedding after treatment of pet areas. Do not use directly on pets.

**SPIDERS:** Apply until damp along and behind baseboards, to window and doorframes, comers, pipes, storage localities, attics, crawl spaces and other areas over which these pests may be present.

CENTIPEDES, EARWIGS, GROUND BEETLES, MILLIPEDES, MOLE CRICKETS, PILLBUGS, SOWBUGS, SCORPIONS, and TICKS: Apply until

damp around doors windows and other places where these pests enter premises. Treat baseboards, storage areas, and other locations where these pests are found.

PANTRY PESTS-GRAIN BEETLES (RUSTY, MERCHANT and SAW-TOOTHED), FLOUR BEETLES (RED AND CONFUSED) CHOCOLATE MOTHS, CIGARETTE BEETLES, CLOVER MITES, CLUSTER FLIES, DRUG STORE BEETLES, ELMLEAF BEETLES, RICE WEEVILS, LESSER GRAIN BORERS, SPIDER BEETLES and TOBACCO MOTHS: Treat exposed stages of these pests. Remove all foodstuffs, utensils and shelf paper from area to be treated. Discard used shelf paper and any infested foodstuffs. Apply spray until damp to shelves and crack and crevices behind and under cupboards and cabinets. Allow spray to dry prior to replacement of shelf paper, food and utensils.

CARPET BEETLES (BLACK, FURNITURE and VARIED): Spray until damp on and under edges of floor coverings, under rugs and furniture and in closets or other localities where these insects are found.

WEBBING CLOTHES MOTHS: Use this product as a crack and crevice treatment in closets and other storage areas where these pests are found. This is an adjunct treatment and will not control moth larvae already on clothes. Do not apply to clothing.

# **OUTDOORS**

**PESTS ON OUTSIDE SURFACES OF BUILDINGS:** For the control of building infestation due to **ANTS, CLOVER MITES, CRICKETS, EARWIGS, MILLIPEDES,** and **SOWBUGS (PILLBUGS).** Spray foundation of building until damp where insects are active and may find entrance up to a height of 2 feet. Apply as a spray to outside of buildings where insects congregate. Spray areas include screens, window frames, eaves, porches, garages, and refuse dumps. Repeat treatment as necessary.

CRAWLING INSECTS: ANTS, COCKROACHES (including ASIAN COCKROACHES) CRICKETS, CENTIPEDES and SILVERFISH. Spray infested surface until damp of patio or picnic area, contacting as many insects as possible. Also spray legs of tables and chairs to repel ants. Spray anthills for best control.

ANTS, LONE STAR TICKS, DOG TICKS, CRICKETS, FLEAS and EARWIGS: Apply thoroughly until damp to infestations. For ants, spray around ant trails and hills.

#### STORAGE AND DISPOSAL
