Based on you response to the Reregistration Eligibility Document, EPA has reregistered the above named product subject to the comments recorded in the succeeding paragraph. This action is taken under the authority of section 4(g)(2)(C) of the Federal Insecticide, Fungicide, and Rodenticide Act, as amended. Reregistration under this section does not eliminate the need for continual reassessment of pesticides. EPA may require submission of data at any time to maintain the registration of your product.

A stamped copy of the product label is enclosed for your records.

Submit one copy of the final printed label before releasing the product in channels of trade with the reregistered labeling.

Make the following changes in the Confidential Statement of Formula (CSF; EPA Form 8570-4), and submit a revised CSF with the final printed labeling.

1. Note that the source products listed on the CSF which utilizes 9.2% sodium hypochlorite sources has not yet been reregistered. A revision of this CSF may be necessary if these source supplies are reregistered at a different active ingredient concentration than 9.2%.

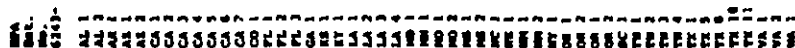
