DIRECTIONS FOR MIXING

MIX CONTENTS OF THIS CAN WITH ENOUGH WATER TO MAKE ONE GALLON OF FINISHED SPRAY. OVERCAP FROM CONTAINER MAY BE USED AS A MEASURING DEVICE FOR MIXING LESSER AMOUNTS, USING 1 CAPFUL (4 OZ.) WITH ENOUGH WATER TO MAKE A QUART. FINISHED SPRAY SHOULD NOT BE LEFT TO STAND OVER-NIGHT. NO MORE SOLUTION SHOULD BE MIXED THAN WILL BE USED AT ONE TIME. SPRAYER SHOULD BE CLEANED AFTER EACH USE WITH WATER AND A SMALL AMOUNT OF LIQUID DETERGENT.

DIRECTIONS FOR APPLICATION

ANY SUITABLE LOW PRESSURE SPRAYER MAY BE USED FOR APPLICATION. APPLY AS A COARSE SPRAY TO AREAS ROACHES AND WATERBUGS MAY INFEST. THOROUGH APPLICATION SHOULD BE MADE A R O U N D BASEBOARDS, WALLS, DOORS AND WINDOW FRAMES, FORCING THE INSECTICIDE INTO ALL CRACKS. LOCALIZED AREAS OF THE FLOOR AND AREAS WHERE THESE INSECTS ARE SEEN RESTING, RUNNING OR HIDING, SHOULD BE THOROUGHLY TREATED.

DO NOT REUSE CONTAINER — DESTROY WHEN EMPTY
