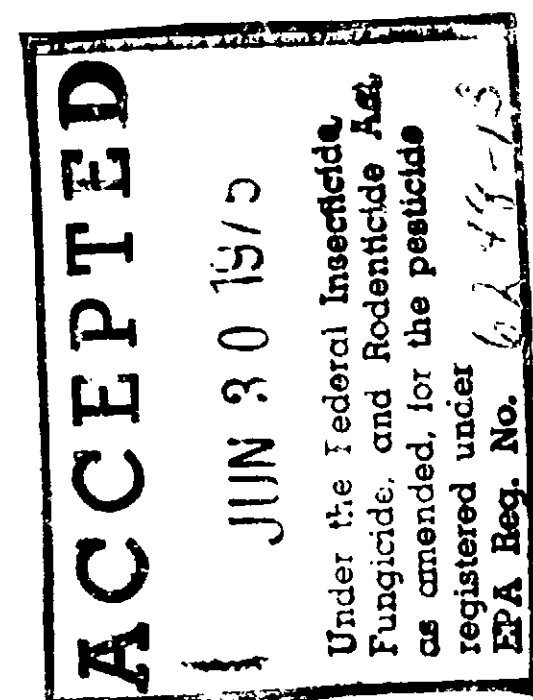

#### FOR SPOT APPLICATION ONLY DIRECTIONS FOR APPLICATION

Make application as a "spot" treatment to localized areas roaches, waterbugs, ants and spiders may infest. Thorough application should be made around baseboards, walls, doors and window frames, forcing the insecticide into all cracks. Localized areas of the floor and areas where these insects are seen resting, running or hiding, should be thoroughly treated. Avoid excessive wetting of asphalt tile, rubber and plastic materials.

#### DO NOT REUSE CONTAINER — DESTROY WHEN EMPTY

Do not use in edible products areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

**Caution:** Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing spray mist. Use with adequate ventilation. Do not apply to areas which will be frequently contacted by children and do not allow them in treated areas until surfaces are dry.
