It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

FOR GENERAL DISINFECTION of hard, non-porous inanimate surfaces (glass, metal, plastic, glazed porcelain, tile, leather, vinyl, enamel and finished wood surfaces) on walls, floors, appliances and furnishings in industrial and commercial offices, rest-rooms and work areas.

CLEANING AND DEODORIZING. Whenever practical, flush away gross soils with water. For cleaning and deodorizing, use 5 to 8 ounces of THIS PRODUCT per gallon of water. Cleaning may be accomplished with a clean mop, sponge, squeegee, wet vacuum system, or a mechanical spraying device. After cleaning remove suspended soils with a clear water rinse, vacuum pick up or by wiping with a clean mop, sponge, squeegee or cloth.

DISINFECTING. Before disinfecting, preclean surfaces as directed above. Then, prepare 5 ounces of THIS DISINFECTANT per gallon of water and thoroughly wet the surfaces to be disinfected.
