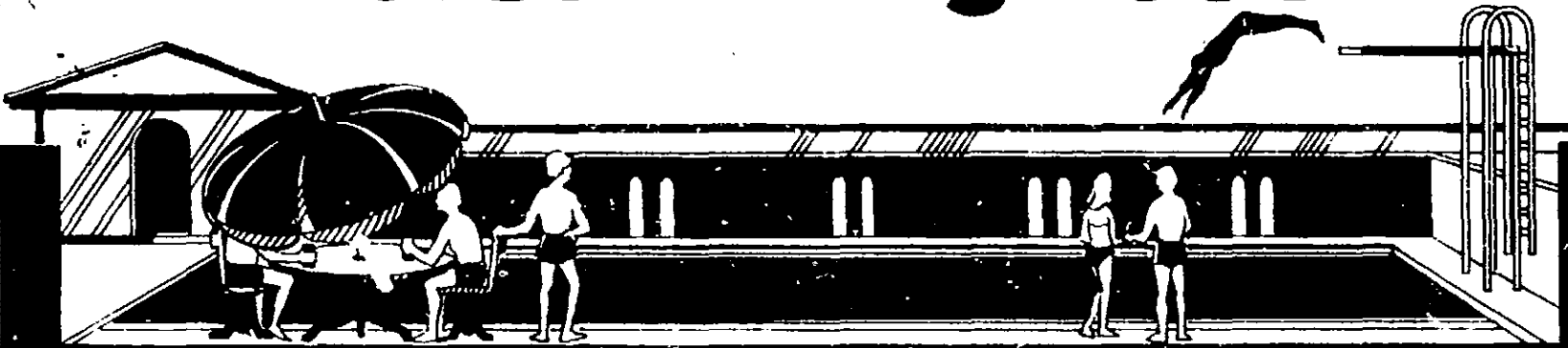

## Directions

For a new pool or for spring start up, superchlorinate with sodium hypochlorite in accordance with label directions for this product.

### For pool maintenance:

- A) Adjust pool water pH to 7.2-7.6 and maintain.
- B) Feed pool water with BROM-O-RINGS by use of mechanical feeder or other suitable device.
- C) Adjust the feeder flow to maintain 1.0 to 2.0 PPM residual chlorine. Check residual chlorine level with a suitable test kit daily or more frequently as required.

### NOTE:

DO NOT MIX WITH ANY OTHER CHEMICALS.  
DO NOT THROW TABLETS DIRECTLY INTO POOL! SPOTTING WILL OCCUR.  
DO NOT REUSE CONTAINER; RINSE EMPTY CONTAINER THOROUGHLY WITH WATER BEFORE DISCARDING.

This product is toxic to fish. Treated effluent should not be discharged where it will drain into lakes, streams, ponds, or public water. Do not contaminate water by cleaning of equipment, or disposal of wastes. Apply this product only as specified on this label.

## Danger-Corrosive

Causes eye damage. May cause burns on broken skin. Irritating to nose and throat if inhaled. May be harmful or fatal if swallowed. Do not get in eyes, on skin or on clothing. Protect eyes when handling. Avoid breathing dust.

**STRONG OXIDIZING MATERIAL:** Contact with organic matter or any foreign material may result in fire or explosive decomposition. Rinse container thoroughly clean with water before discarding.
