

PHYSICAL OR CHEMICAL HAZARDS:

STRONG OXIDIZING AGENT

Mix only into water. Use clean dry utensils. Do not add this product to any dispensing device containing the remains of any other product. Such use may cause a violent reaction leading to fire or explosion. Contamination with moisture, organic matter or other chemicals will start a chemical reaction and generate heat, chlorine gas (and possible fire and explosion). In case of contamination or decomposition, do not reseal container. If possible, isolate container in open air or well ventilated area. Flood with large volumes of water, if necessary.

PRACTICAL TREATMENT (FIRST AID)

IF SWALLOWED: Promptly drink large quantities of water. DO NOT induce vomiting. Get medical attention. Avoid alcohol.

IF ON SKIN: Brush off excess chemical and flush skin with cold water for at least 15 minutes. If irritation persists get medical attention.

IF IN EYES: Flush with cold water for at least 15 minutes. Get medical attention.

IF INHALED: Remove person to fresh air. Get medical attention.

STORAGE AND DISPOSAL

Keep this product dry in a tightly closed container when not in use. Store in a cool, dry, well ventilated area away from heat or open flame. In case of decomposition, isolate container (if possible) and flood area with large amounts of water to dissolve all material before discarding this container. Do not reuse empty container, but place in trash collection. Do not contaminate food or feed by storage, disposal, or cleaning of equipment.

DIRECTIONS FOR USE
General Classification

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

For a new pool or spa, or for re-opening, shock with granular chlorine or other fast dissolving chlorine products to provide approximately 10 ppm available chlorine. Follow instructions on label of product being used.

FOR MAINTENANCE

1. Bring pool water pH within a range of 7.2 to 7.6. Add dry acid to reduce pH or soda ash to increase pH as prescribed on labels.
2. Place this product in a mechanical feeder or other suitable device.
3. Adjust the feeder flow to maintain a 1 to 3 ppm chlorine residual for pools (2 to 4 ppm for spas).
4. Test your water daily and make the necessary adjustments with appropriate chemicals.

Do not mix this product with any other chemicals.

Do not throw tablets directly into pool or spa--spotting or etching will occur.
