To start chlorination, place Lablets in your slimmer. ᠄᠆ᢂᢗᡆᢏᢃᢅᠴ one 1-roch. I/O ounce tablet per 0,000 gallons of pool water every day, or as needed. Her enough tablets to maintain a chloring residual of 1 to 3 ppm.

Test your pool water daily and make necessary adjustments with appropriate pool chemicals.

Run pump and filter until tablets are dissolved.

Do not throw tablets directly into pool--spotting or etching wall occur.

SHOCK TREAT

Shock your pool every two weeks, and after a rain or at the first sight of green or cloudy water. Extremes in temperature, swimmer loads, wind and dust can cause bacteria, algae and debris to accumulate in pool water and can require weekly shock treatment. Add 5 tablets to slimmer per 1,000 gallons of water to provide approximately 10 ppm available chlorine. Treat pool at night—do not allow simmers to enter pool until chlorine level has dropped to 3 ppm.

STORAGE AND DISPOSAL
