The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below prior to release for shipment of product bearing the amended labeling.

- 1. The words ACTIVE INGREDIENTS and INERT INGREDIENTS must be printed in type of the same size and be given equal prominence.
- 2. Based on the current Confidential Statement of Formulas (CSFs) dated July 18, 1989 for the subject products will not meet the label claim for the active ingredients, diatomaceous earth. As stated in our letter, dated rebruary 28, 1990, the lower limit of the active ingredient (column 14b) must be the <u>same</u> as the label claim. The purity of diatomaceous earth (EPA Reg. No. 59510-1) has been reevaluated to be 100% pure active. Therefore the percentage of diatomaceous earth should be 100% x 87.9 = 87.9% or 88% for EPA Reg. No. 6330-1 and EPA Reg. No. 6330-32 and 100% x 88.5% = 88.5% for EPA Reg. No. 6330-9 as it appears on the label claim. Please revise the CSFs to agree with the Jabel claim.


