### FIRST AID

In case of contact, immediately flush eyes or skin with plenty of water. For eyes, call a physician. Remove and wash contaminated clothes before reuse.

If swallowed, drink a large quantity of milk, egg whites, gelatin solution, or if these are not available, drink large quantities of water.

### NOTE TO PHYSICIAN

### DIRECTIONS FOR USE

**General:** Recommend metered pumping directly into gudgeons or feed tank; also, dilution before introduction into process.

**Hide Soaking:** Add diluted to vats, drums or hide processors, using one pound of liquid preservative per 1000 lbs. of hides or 500 gallons of water.

**Pickling:** Add diluted to vats, drums or hide processors, using one and one-half pounds of liquid preservative per 1000 lbs. of original hides put into process. Add 30 minutes before end of pickling operation.

**Chrome Tannage:** Add diluted to vats, drums or hide processors at the end of chrome tannage or during neutralization, using one pound of liquid preservative per 1000 lbs. of original hides put into process. For export chrome stock, increase dosage as needed up to two pounds liquid per 1000 lbs. of original hides.

**Color and Fatliquoring:** Add diluted to drums or Concentrics during fatliquoring step, using one-half pound of liquid preservative per 1000 lbs. of wet blue stock.
