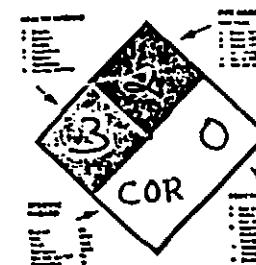

FIRST AID
