Dig a trench approximately 30 inches deep by 6 inches wide around each side of the foundation. Do not dig deeper than the top of the footing, however, if it is shallower than 30 inches. Apply 4 gallons per 5 linear feet of trench. Inspect treated area annually and repeat application if necessary.
