It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Disinfectant - Cleaner - Sanitizer - Fungicide - Mildewstat - Virucide which is effective in water up to 400 ppm hardness in the presence of 5% serum contamination.

Apply 0.5 oz per gallon to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks, tile, porcelain, and bedframes with a cloth, mop or mechanical spray device so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

Fungicidal Performance - MC-256 WITH HARD WATER TOLERANCE is an effective fungicide against *Trichophyton mentagrophytes* (the athlete's foot fungus) when used on surfaces in areas such as locker rooms, dressing rooms, showers and bath areas, exercise facilities, etc., at 0.5 oz/gallon.

Mold and Mildew Control - At 0.5 oz/gallon, MC-256 WITH HARD WATER TOLERANCE will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard, non-porous surfaces (as indicated in general instructions above). Allow to dry on surface and repeat when mildew growth returns.

Virucidal Performance - At 0.5 oz per gallon use-level, MC-256 WITH HARD WATER TOLERANCE was evaluated in the presence of 5% serum and 400 ppm hard water and found to be effective against the following viruses: Influenza A/Brazil, Herpes Simplex and Vaccinia on inanimate environmental surfaces.

Sanitizing Non-Food Contact Surfaces (such as floors, walls, tables, etc.) At 0.5 oz per 5.5 gallon use-level, MC-256 WITH HARD WATER TOLERANCE is an effective sanitizer against *Staphylococcus aureus* and *Klebsiella pneumoniae* on hard porous and non-porous environmental surfaces.
