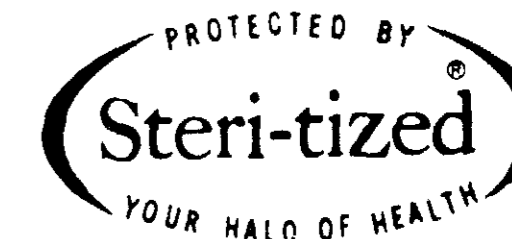

Steri-tized 520

PRODUCT: Steri-tized 520 is a complex organo-mercuric complex in powder form, for use on coatings for fabrics, to achieve mildewstasis, bacteriastasis, and fungistasis. The effects of the use of Steri-tized 520 are fast to leaching, and will for all practical purposes, last for the effective life of the product.

USES: Steri-tized 520 has been created for application in lakes, rubber, paint, vinyl, or any other coated fabric formulae. It may be ground together with pigment dyes and chlorinated paraffin, or with chlorinated rubber. It may be used in the tupper process, and has found wide use in all phases of the rubber industry.

APPLICATION: Steri-tized 520 is applied so that 0.45% residual is applied to the coating. This residual is based on the weight of the material with which it is combined. An average ratio is 1 lb of Steri-tized 520 per 99.5 lbs of media. In cases where severe leaching is anticipated, double the amount. It is important that Steri-tized 520 be thoroughly mixed with the host material.

CAUTION: Steri-tized 520 is NON-TOXIC after application, but is toxic in concentrated form and must be handled carefully. Contact with skin, even for short periods may result in skin irritation. Wash hands promptly with cold water directly after handling. In the event of burning or blistering, treat the afflicted parts, after washing, with a strong tea brew. In severe cases, get medical aid.
