INSTRUCTION

No Rinsing — Do Not Add Water

FOR RUGS AND CARPETS:

May be used with any hand or electric tank-type carpet cleaner, a scrubbing brush or sponge-mop.

First sweep or vacuum. Pour 3-WAY FOAMCLEN into tank of carpet cleaner and follow manufacturer's directions; or, pour into pail and dip in brush or sponge-mop. Apply to rug in a rocking motion covering small area at a time. Use back of brush as squeegee or a towel to remove soil and excess foam. Repeat process over entire rug being sure to overlap each area. For straw, fibre, grass and reed rugs follow directions for upholstery.

FOR UPHOLSTERY:

First brush or vacuum. Pour a small quantity of 3-WAY FOAMCLEN into a bowl. Use cellulose or natural sponge to work all liquid into a foam. A beater may also be used. Clean in a circular motion with foam and sponge, over a small area at a time. Wipe off dirt and excess foam with toweling in direction of nap. Repeat process over entire piece, being sure to overlap each area. Safe to use on foam-rubber padded upholstery.

OTHER USES:

3-WAY FOAMCLEN can also be used on automobile upholstery, draperies, lamp shades, tapestries and venetian blind tape and cord. Also plastics, silk, rayon, mohair and velvet fabrics.

FOR HARD TO REMOVE STAINS:

Make a cupful of foam, cover the stain with this foam and let it stand 15 minutes. Then brush or sponge area with more foam, wipe dry with toweling.

IMPORTANT:

Test all fabrics before cleaning. Clean thoroughly an inconspicuous spot. Let dry thoroughly and inspect the color. Will not affect any material not affected by water . . . Protect legs of furniture from contact with damp rugs. For full moth protection, fabric must be thoroughly wetted, it must be re-treated after laundering, numerous dry cleanings or excessive wear.
