DIRECTIONS

To control most weeds and grasses for extended periods on non-cropland areas such as industrial plant sites, parking lots, loading ramps and around storage buildings and similar non-crop areas, apply 1.5 to 4 gallons per 1000 square feet of Weed Killer ± 6 Liquid with Drift Reducer after the most predominant weeds have emerged.
