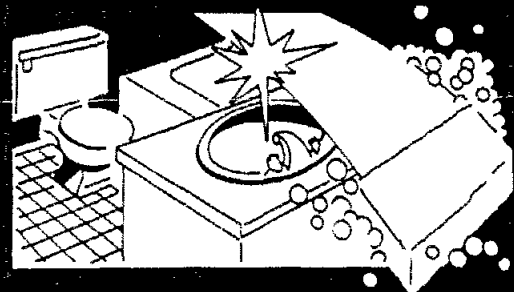

DISINFECTION AND CLEANING:

Disinfects, cleans and deodorizes hard non-porous surfaces such as bathroom tiles, walls, fixtures, shower stalls, sinks, bathtubs, hampers, tables and chairs, proceed as indicated below:

- Gross filth or heavy soil should be removed prior to application as a one-step cleaner/disinfectant.
- Shake well before using.
- Hold 6-8 inches away from surface.
- With arrow pointed away, spray evenly covering area thoroughly with white foam.
- To disinfect, allow to stay in contact 10 minutes.
- Wipe off with clean cloth or sponge.

When used as directed, Cleaner/Disinfectant demonstrates effective disinfection against *Staphylococcus aureus*, *Salmonella choleraesuis* and *Pseudomonas aeruginosa*.

MOLD AND MILDEWSTAT: Cleaner/Disinfectant prevents and controls mold and mildew and the odors they cause on hard non-porous inanimate surfaces.

This product is not to be used as a terminal sterilant/high level disinfectant on any surface or instrument that (1) is introduced directly into the human body, either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. This product may be used to pre-clean or decontaminate critical or semi-critical medical devices prior to sterilization or high-level disinfection.
