1. Delete "Use additional units for remote rooms or where free flow of mist is not assured". This statement conflicts with the precaution "Do not use more than one fogger per room."
2. Under the ENVIRONMENTAL HAZARDS section add "This pesticide is extremely toxic to fish and other aquatic organisms."
3. Submit two (2) copies of your final printed labeling before you release the product for shipment.

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. DO NOT use more than one fogger per room. DO NOT use in small, enclosed spaces such as closets or cabinets, or under counters or tables. DO NOT use in a room 5 ft. x 5 ft. or smaller. Instead, allow fog to enter from other rooms. Turn off ALL ignition sources such as pilot lights (shut off all gas valves), other open flames or running electrical appliances that cycle off and on (i.e. refrigerators, thermostats, etc. Call your gas utility or management company if you need assistance with your pilot lights.

#### SHAKE WELL BEFORE USE

#### KEEP CONTAINER UPRIGHT

Cover exposed foods, dishes and food handling equipment. Open cabinets and doors to area to be treated. Close doors and windows. Point valve opening away from face and eyes when releasing. Use additional units for remote rooms or where free flow of mist is not assured. Do not remain in the area during treatment and ventilate thoroughly before re-entry.

**TO OPERATE VALVE:** To lock valve in open position for automatic discharge, press the valve button all the way down, hooking the catch. Then place fogger on stand or table in the center of the room with valve locked open, placing several layers of newspaper or pad under fogger. Repeat spraying when necessary.

**TO KILL TICKS AND FLEAS:** Old bedding should be replaced with clean bedding after treatment. Pet's should be treated with a registered product for flea and tick control in conjunction with this treatment.

#### PRECAUTIONARY STATEMENTS

#### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

#### CAUTION

Harmful if swallowed or absorbed through skin. Do not breathe vapors or spray mist. Avoid contact with skin or eyes. Avoid contamination of food or foodstuffs. Do not use in commercial food processing, preparation, food storage or serving areas. In the home, all food processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Exposed food should be covered or removed. Remove pets, birds and cover fish aquariums before spraying.
