**TO CLEAN:**

**TO DISINFECT:** Repeat application making sure to wet all surfaces thoroughly and allow to stand 30 seconds minimum before wiping with a clean, damp sponge or cloth. Rinse thoroughly. Container may be refilled with Spray Nine®. Do not reuse empty bottle with any other product. To dispose triple rinse and offer for recycling or wrap and put in trash.
