

TERMITE CONTROL

Add 1 gallon of Chlordane EM-8 to 95 gallons of water (1% emulsion) Apply the 1% emulsion as follows.

1—SLAB-TYPE CONSTRUCTION

- a Apply 1 gallon per 10 square feet as an overall pre construction treatment under the slab and along attached porches or entrance platforms.
- b Apply 2 gallons per 5 lineal feet to critical areas under the slab as pre-construction treatment, such as along the inside of the foundation walls and around utility entrances and interior partition foundation walls.

2—BUILDINGS WITH CRAWL SPACES

- a Apply 2 gallons per 5 lineal feet in a trench along the outside walls, including entrance platforms and porches where the foundation is not more than 15-18 inches deep. If over 15-18 inches deep but not over 30 inches, apply 4 gallons per 5 lineal feet. Do not go deeper than the top of the footing.
- b Apply 2 gallons per 5 lineal feet as a trenching application to critical areas under the house, such as along the inside of foundation walls and around piers and utility entrances. If trench is deeper than 15-18 inches but not over 30 inches apply 4 gallons per 5 lineal feet. Do not go deeper than the top of the footing.
- c Apply 1 gallon per 10 square feet of soil surface as a pre construction treatment where the attached porches, entrance platforms, utility entrances have covering slab on fill of ground.
- d Apply 1 gallon per 5 lineal feet of wall to voids in hollow masonry units of the foundation.

3—BUILDINGS WITH BASEMENTS

- a Apply 1 gallon per 10 square feet as an overall pre construction treatment under the basement flooring, attached porches, entrance platforms, utility entrances and

similar situation where slab fill is at ground level.

- b Apply 2 gallons per 5 lineal feet in a trench along the outside of foundation walls, including entrance platforms and porches where the foundation is not more than 15-18 inches deep. If over 15-18 inches deep but not over 30 inches, apply 4 gallons per 5 lineal feet. Do not go deeper than the top of the footing.
- c Apply 2 gallons per 5 lineal feet as a trenching application to critical areas under the house such as along the inside of foundation walls, porches, entrances and piers. If trench is deeper than 15-18 inches but not over 30 inches, apply 4 gallons per 5 lineal feet. Do not go deeper than the top of the footing.
- d Treat all voids in hollow masonry units of the foundation at the rate of 1 gallon per 5 lineal feet of wall.

Note: For buildings with deep footings, dig trench 30 inches deep. Do not dig trench below level of footing.

4—BUILDINGS HAVING BASEMENTS OR CRAWL SPACES

Dig a trench along the outside of the foundation walls. In brick or hollow block or concrete foundations, dig a trench to, but not below, the footing. Then as the trench is filled, treat the soil at the rate of 4 gallons per 10 lineal feet for each foot of depth. A trench 3 feet deep would require 12 gallons per 10 lineal feet. The objective is to establish a treated soil barrier which will prevent termite entry. Other critical areas may also require treatment. It is suggested that you consult the State Extension Service for advice.

| Ants, Boxelder bugs, Carpet beetles, Centipedes, Roaches, Scorpions, Silverfish, Spiders, Crickets, Waterbugs | 2-3% Spray | Thoroughly spray around doorsills, baseboards, closets, storage cabinets, openings around water pipes, heat and air conditioning ducts, window frames, wall cracks, electrical outlets or wherever these insects may enter, congregate, feed or hide in the home. |
| Clothes moths | 2% Spray | Thoroughly dampen all surfaces of clothing, blankets and other woolen cloth. Treated articles should be dried and then placed immediately in storage. Dry clean before using them as clothing or bedding. |
| Mosquitoes Wasps | 2-3% Spray | Thoroughly spray around windows and areas frequented by mosquitoes. To prevent the entry of these insects into buildings thoroughly spray window frames, doorsills and selected areas of porches where they tend to alight and congregate. Spray the wasp nest after dark when all the insects have returned to the nest. |
| Brown dog tick | 2-3% Spray | Thoroughly spray or paint with a coarse wet spray infested areas, baseboards, window and door frames, wall cracks, sleeping quarters of household pets and localized areas of floors and floor coverings. Use fresh bedding after treatment. Do not spray pets or other animals. |

Do not allow children in treated areas until surfaces are dry.

DIRECTIONS FOR APPLICATION WITHIN FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS

Application within **FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS** - Places other than private residences in which exposed food is held, processed, prepared or served.

FOOD AREAS - APPLICATION LIMITED TO CRACK AND CREVICE TREATMENT ONLY - Include areas for receiving, storage, packing (canning, bottling, wrapping, boxing) preparing, edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups). Serving areas (when food is exposed and facility is in operation, also would be considered a food area).

Apply a 2% to 3% spray of material directly into cracks and crevices using equipment capable of delivering a pin stream of insecticide in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases where Ants, Boxelder Bugs, Carpet Beetles, Centipedes, Roaches, Silverfish, Spiders, Crickets and Waterbugs hide. Do not use this product in conduits, motor housings, and electrical switch boxes. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.
