



# WARNING

### ANTIDOTE AND FIRST AID TREATMENT

ATROPINE is the emergency antidote for VAPONA Insecticide poisoning. Consult your physician about obtaining an adequate supply of 1/100grain atropine tablets for emergency use. Call a PHYSICIAN IMME-DIATELY IN ALL CASES OF SUSPECTED POISONING.

**INTERNAL:** If the material has been swallowed, induce vomiting immediately. This may be done by introducing a finger into the throat or by giving warm salt water (1 tablespoon of salt to a glass of water). NEVER GIVE ANYTHING BY MOUTH TO AN UNCONSCIOUS PERSON.

**EXTERNAL:** If the material has been spilled on the skin, immediately remove patient from the vicinity of the insecticide, remove all contaminated clothing, and wash skin with soap and running water. If the material gets into the eyes, wash immediately with running water for at least ten minutes.

**TREATMENT:** Atropine is the specific therapeutic antagonist of choice against parasympathetic nervous stimulation. If there are signs of parasympathetic stimulation, atropine sulfate should be injected at 10-minute intervals, in doses of 1 to 2 milligrams until complete atropinzation

Repeated exposure to cholinesterase inhibitors may, without warning, cause prolonged susceptibility to very small doses of any cholinesterase

Allow no further exposure until time for cholinesterase regeneration has been allowed as determined by blood test.
