DIRECTIONS

FOR BEST RESULTS SOIL SHOULD BE MOIST AT THE TIME OF APPLICATION. Dry soil may not allow desirable turf to resist the action of chemicals. If soil is dry, first spray each acre (using fine spray or mist) with 50 gals. of water containing 2 qts. of Wetting Agent to assist penetration of irrigation water.

RECOMMENDED RATES TO TREAT ONE (1) ACRE

Mix at the rate of **2½ pints** MSMA-120 in **40 gallons** of water. Thoroughly mix by agitation or recirculating solution in spray tank prior to application.

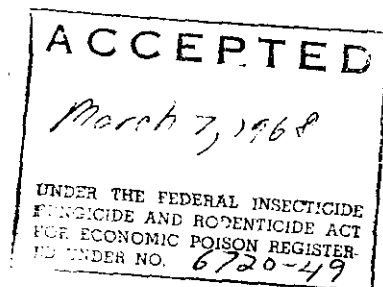
To decrease run-off and increase effectiveness of leaf absorption, add **1 to 2 pints** of Wetting Agent to this mixture.

Two or more treatments about 5 - 7 days apart may be necessary. MSMA-120 is effective at above rates if air temperature is 80°F. For temperatures below 80°F. use twice the amount of MSMA-120 to treat the same area.

IMPORTANT: DO NOT water for at least 24 hours after treatment. DO NOT use on. ST. AUGUSTINE, CARPET OR CENTIPEDE GRASSES.
