Consult the table below to determine the required amount of SMCP 50% CHLORDANE to be added to water for a 1% emulsion:

The objective is to establish a treated soil barrier which will prevent termite entry. Other critical areas may also require treatment. It is suggested that you consult the State Extension Service for advice.

FIRE ANT CONTROL

For the control of fire ants on home lawns, golf courses, parks, ornamental turf, cemeteries and recreation areas, apply SMCP 50% CHLORDANE at the rate of 1/2 pint in 35 gallons of water to treat 9000 square feet.

Keep children and pets off treated areas until material has been washed into the soil by watering or rain and grass is dry. Do not treat when soil is wet. Do not apply to pasture and rangeland. Do not contaminate food or feed crops.


