#### DIRECTIONS FOR USE

**CHINCH BUGS AND SOD WEBWORMS IN TURF:**  
Apply as a broadcast application at the rate of 5 - 7 lbs. per 1000 sq. ft. or 200 - 300 lbs. per acre. Water after application. (Use setting #5 on Model B Cyclone Spreader.)

**CAUTION:** Keep children and pets off treated areas until lawn is dry.

Fish may be killed if their water is contaminated with this product.

This product is toxic to fish and wildlife. Birds feeding on treated areas may be killed. Keep out of any body of water. DO NOT apply where runoff is likely to occur. Apply this product only as specified on this label.
