Apply Malathion dust thoroughly to all areas where insects hide or through which they may enter the building, including around water pipes, wall voids, under and behind lockers, and cabinets.

Note: 5% Malathion PCO Dust is useful where sprays might be difficult to apply as in wall voids. Avoid the use of dust where there is wind, sweeping, traffic or other activity that would cause the dust to be transferred or become air-borne. Any dust left in the open, after application, must be brushed into cracks or otherwise removed.

FOR THE CONTROL OF FLEAS AND BROWN DOG TICKS, thoroughly treat floor areas, cracks and crevices, sleeping quarters of animals, and other areas frequented by these pests.
