For Flies, Mosquitoes, and Gnats: Close toward ceiling in all directions until room is empty. Keep doors closed for at least 15 minutes. Ventilate the room when treatment is completed.

Wasps: Application should be made in the late evening when insects are at rest. Spray liberally into hiding and breeding places, contacting as many insects as possible. Repeat as necessary.

## CAUTION KEEP OUT OF REACH OF CHILDREN

Avoid contamination of feed and foodstuffs. Use in food processing plants only when the plant is not in operation. Foods should be removed or covered during treatment.
