USE DIRECTIONS - FOR F T APPLICATION ONLY

Use DURSBAN®[®] Home Edition spray to control cockroaches, silverfish, spiders and other pests specified below. Apply as a surface spray or spot spray to localized areas where pests may occur. Spray surfaces until wet. Repeat as needed.

COCKROACHES, ANTS & CRICKETS, SILVERFISH, SPIDERS: Spray areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices in walls, along baseboards and doors and frames, behind and beneath sinks, stoves, refrigerators and cabinets, and around drainage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly.

BROWN DOG TICKS: To control these pests, thoroughly apply as a spot treatment to infested areas, such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor covering where the pest may be present. Old bedding of pets should be removed and replaced with clean fresh bedding after treatment. DO NOT SPRAY PETS WITH THIS PRODUCT.

FLIES AND MOSQUITOES: Use only out-of-doors as an aid in reducing annoyance from these insects. Spray outside surfaces of windows and door frames, as well as other areas where these pests may enter this home. Also spray dark corners and localized resting areas for flies and larvae, step porches, patios and lawns where the insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.

DO NOT USE IN EDIBLE PRODUCTS AREAS OF FOOD PROCESSING PLANTS, RESTAURANTS OR OTHER AREAS WHERE FOOD IS COMMERCIALLY PREPARED OR PROCESSED. DO NOT USE IN SERVING AREAS WHILE FOOD IS EXPOSED.
