- If the product is intended to be used in commercial greenhouses, then you must add the following worker protection statement to the label:

Do not enter treated areas for 24 hours after application unless protective clothing is worn.

If the product is intended to be used in home greenhouses, then the claim for use in greenhouses should be qualified accordingly.

If this condition is not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of this condition.

IMPORTANT: It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SMCP PELLETIZED SLUG AND SNAIL BAIT is very effective for the control of slugs and snails around the home, in flower gardens, and in ornamental greenhouses. The bait should be applied to soil around plants but not directly to plant foliage. CAUTION: Do not use around food crops.

Sprinkle one pound uniformly over 1,000 sq. ft. of area to be treated. For best results lightly water the area to be treated before applying the bait. When making applications, special attention should be given to treating areas around flower beds, under greenhouse benches and around building foundations. Repeat applications as necessary to keep areas free of slugs and snails.

RESTRICTIONS: Do not use on plants grown for food. Do not put bait in piles. Scatter bait so that it is hardly visible on the grounds.

NOTICE: Seller's guaranty shall be limited to the terms of the label and subject thereto. The buyer assumes any risk to persons or property arising out of use or handling, and accepts the product on these conditions.
