

SMCP CRUMBLIZED SLUG AND SNAIL BAIT is very effective for the control of
slugs and snails around the home, in flower gardens, and in ornamental
greenhouses. The bait should be applied to soil around plants but not
directly to plant foliage. CAUTION: Do not use around food crops.

Sprinkle one pound uniformly over 1,000 sq. ft. of area to be treated. For
best results lightly water the area to be treated before applying the
bait. When making applications, special attention should be given to
treating areas around flower beds, under greenhouse benches and around
building foundations. Repeat applications as necessary to keep areas free
of slugs and snails.

RESTRICTIONS: Do not use on plants grown for food. Do not put bait in piles. Scatter bait so that it is hardly visible on the grounds.

PRECAUTIONARY STATEMENTS
Hazardous to humans and domestic animals

CAUTION: May be harmful if swallowed, inhaled, or absorbed through skin. Do not get in eyes, on skin, or on clothing. Wash thoroughly with soap and water before reuse. Do not contaminate feed or food. Keep out of reach of children and domestic pets.

Do not enter treated areas for 24 hours after application unless protective clothing is worn.

If poisoning occurs, obtain prompt medical attention. **ANTIDOTE:** Atropine Sulfate.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish and very highly toxic to birds. Do not apply directly to water or wetlands (swamps, bogs, marshes, and potholes).
