
DIRECTIONS FOR USE

How to Mix and Apply: For lawns, measure the area to be sprayed. For all other applications, apply as a thorough cover spray. Make applications when insects first appear. Repeat application as needed or as noted and surface applications. Thorough coverage is important. Use clean sprayer Flush sprayer after each use. See RATE CHART below for complete Insect List — Use dosage shown unless otherwise indicated. (Note: Do not use on certain ferns, poinsettia, hibiscus, papaya, pilea, gardenia and orchids since injury may occur.) Use contents within 6 months of opening. Keep tightly capped.


