DIRECTIONS FOR USE

Space Spray — Undiluted in Aerosol Generators — to kill Flies, Mosquitoes, Small Flying Moths and Gnats: Close room and shut off all air conditioning or ventilating equipment. Apply at the rate of 1.0 oz. of undiluted Concentrate per 1,000 cubic feet of space. Direct output from aerosol generator upward towards upper corners of room and ceiling. Leave room closed for one half hour. Do not remain in treated areas. Ventilate the area after treatment is completed.

Space Spray — Diluted for Ordinary Mechanical Fogging Equipment — to kill Flies, Mosquitoes, Small Flying Moths and Gnats: Close room and shut off all air conditioning or ventilating equipment. Dilute Concentrate with oil at the rate of 1 part Concentrate plus 29 parts of oil and mix well. Apply at the rate of 50 fluid ounces dilute spray (0.4 gallons) per 25,000 cubic feet of space. Direct fog upward towards upper corners of room and ceiling area. Leave room closed for one half hour. Do not remain in treated areas. Ventilate the area after treatment is completed.

Contact Spray — Diluted for Use with Sprayers that Give Large, Wetting Spray Particles — To kill Cockroaches and Accessory Stages of Granary Insects: Granary Weevils, Rice Weevils, Confused Flour Beetle, Red Flour Beetle, Meal Moth Larvae and Adults, Caddis, Grain Mites and Saw-toothed Grain Beetles: Dilute Concentrate with oil at the rate of 1 part Concentrate plus 29 parts of oil and mix well. Spray outside walls of grain bins, flooring, around base of milling machinery, wall and baseboards, areas behind cabinets, around pipes and other insect harbourages using one gallon spray per 1,000 cubic feet of space. Force spray into all cracks and crevices. Repeat application as necessary.

CAUTION: Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using the product in these areas, apply only when the facility is not in operation.

NOTE: Infested stored food products should be fumigated or treated by other effective methods using an approved product intended for this purpose.



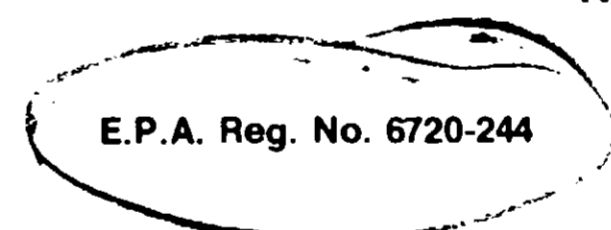

It can also be diluted with oil specified above and applied as a contact spray to kill crawling insects shown on this label.

CAUTIONS

HUMAN CAUTIONS: Harmful if swallowed. Do not breathe spray mist. Wear mask or respirator of a type recommended by the U.S. Bureau of Mines to give adequate protection against this material.
