(Treatment) - Give atropine preferably by injection, grains 1/30 to 1/15 (2 to 4 mg.), at once and every hour or oftener as needed to achieve and maintain full atropinization. 2-PAM is also antidotal and may be administered in conjunction with atropine. Never give morphine. Clear chest by postural drainage. Artificial respiration or oxygen administration may be necessary. Treat symptomatically. Observe patient continuously for 48 hours. PARATHION is a Cholinesterase inhibitor and treatment of poisoning should include the use of ATROPINE. Toxaphene produces central nervous system excitation which responds to the barbituric derivatives.
