GENERAL DIRECTIONS

MALATHION 50 EMULSIFIABLE LIQUID is a specially prepared concentrate for use in conventional application equipment both indoors and outdoors.

USE AND DIRECTIONS FOR APPLICATION:

USE: Household, Restaurants, Theaters, Food Handling Establishments, Industrial Plants, Warehouses.

INSECT: Flies, Mosquitoes, Roaches, Ants, Spiders, Silverfish, Crickets, Clovermites, Earwigs, Fleas, Bedbugs.

DILUTION: **OUTSIDE USES**—Dilute 1 part concentrate with 25 parts of water, fuel oil or diesel oil.

INSIDE USES—Dilute 5 fluid ounces per gallon of water.

APPLICATION: **OUTSIDE USES**—Apply as a space spray *OR LOW PRESSURE WET SPRAY*

INSIDE USES—Apply according to standard PCO practices, either as a coarse wet spray or a pin thin stream of spray for crack and crevice treatment.

DIRECTIONS FOR APPLICATION To Be Applied By Pest Control Operators Only OUTSIDE USES

For temporary control of mosquitoes, flies and small insects, apply as a space spray. For control of fleas, apply as a coarse, low pressure spray at the rate of 1 or 2% per 1000 sq.ft., depending upon moisture conditions, and using suitable application equipment. Spray when pests first appear; repeat when needed. Avoid applying oil-based formulations to valuable ornamental plants as injury may occur. This product is toxic to fish. Keep out of any body of water.

INSIDE USES

A. GENERAL USES—OTHER THAN FOOD HANDLING ESTABLISHMENTS: For control of roaches, ants, spiders, fleas, bedbugs, silverfish, crickets, clovermites and earwigs, apply as a coarse wet spray by means of a low pressure sprayer to localized areas insects may infest. Treat infested areas around baseboards, cracks, walls, door and window frames, beneath and behind sinks, stoves, refrigerators and cabinets; around plumbing and other utility installations, localized areas of floors and other areas where pests have been seen nesting, running or hiding. Repeat application as necessary to maintain effective control. Avoid contamination of food processing utensils.

B. FOOD HANDLING ESTABLISHMENTS—(Places other than private residences in which food is held, processed, prepared and/or served.) For control of roaches, ants, spiders, silverfish, crickets and clovermites.

NON-FOOD AREAS

Includes garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling).

Apply as a coarse wet spray by means of a low pressure sprayer to baseboard areas, around water pipes, surfaces behind and beneath sinks, lockers, tables, pallets and similar areas where pests hide or through which they may enter.

FOOD AREAS

Includes receiving, serving, storage (dry, cold, frozen, raw), packaging (canning, bottling, wrapping, boxing), preparing (cleaning, slicing, cooking, grinding), edible waste storage, enclosed processing systems (mills, dairies, edible oils, syrups.) **Limited To Crack And Crevice Treatment Only!**

Apply a pin thin stream of spray by means of a low pressure sprayer in small amounts to crack and crevices where insects hide or through which they may enter the building. Includes expansion joints, spaces between equipment and floors, and openings leading to voids and hollow spaces in walls, equipment legs and bases. Care should be taken to avoid depositing the product into exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces. MALATHION 50 EMULSIFIABLE LIQUID is not recommended for use in conduits, motor housings or switch and junction boxes because of shock hazard. Applications of MALATHION 50 EMULSIFIABLE LIQUID in food areas of food handling establishments other than as a crack and crevice treatment are not permitted.

CAUTION: KEEP OUT OF REACH OF CHILDREN

PRECAUTIONS IN USING

Store in a safe place. Children or animals must not be able to reach or handle the concentrate or diluted emulsion. Harmful if swallowed. Avoid breathing of spray mist. Avoid contact with skin. In case of contact, wash immediately with soap and water. Do not contaminate feed, water or food-stuffs. Do not reuse empty container. Destroy it by perforating or crushing. Dispose of empty containers, spillage and spray wastes by burying in a safe place away from water supplies. Do not use, pour, spill or store near heat or open flame.
