It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

TRUE PRODUCTS ALGAEICIDE is used in swimming pools, exterior spas, whirlpools, hot tubs, and minimum effectiveness pools, spas, whirlpools, hot tubs, and heavy growth of algae should be cleaned prior to using T

For pools having just visible algae growth add an initial 4 fluid ounces of TRUE PRODUCTS ALGAEICIDE per 1,000 gallons of water. For treatment of a pool with settled algae debris by cleaning. For treatment of a pool add initially 39 to 71 fluid ounces of TRUE PRODUCTS ALGAEICIDE per 10,000 gallons of water. Subsequent additions of 4 of TRUE PRODUCTS ALGAEICIDE per 10,000 gallons of water every 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, or decorative fountains having algae require an initial dose of 7 to 11 fluid ounces of TRUE PRODUCTS ALGAEICIDE per 1000 gallons of water. For treatment of a freshly cleaned hot tub, or decorative fountain, add initially 4 fluid ounces of TRUE PRODUCTS ALGAEICIDE per 1,000 gallons of water.

Subsequent additions of 2 to 3 fluid ounces of TRUE PRODUCTS ALGAEICIDE should be made every 5 to 7 days after initial treatment.

TRUE PRODUCTS ALGAEICIDE is compatible with chlorine used to treat pools and spas and is effective against algae. TRUE PRODUCTS ALGAEICIDE can be used in conjunction with chlorine chemicals and may reduce the amount of chlorine required. However, do not mix TRUE PRODUCTS ALGAEICIDE with liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and discarded with clear water. All pesticides should be kept out of reach of children and away from food.
