STATEMENT OF PRACTICAL TREATMENT

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes call a physician. Remove and wash contaminated clothing before reuse.
If swallowed drink promptly a large quantity of milk, egg whites, gelatin solution, or if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.
NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression, and convulsion may be needed.

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

Barquat 4280-Z is a concentrate for formulating purposes only. Use only in accordance with directions in the Technical Bulletin from the manufacturer.
NOTE: This product should not be used or compounded with any reducing or oxidizing agents (such as calcium hypochlorite, solid perchlorate, or nitric acid) since such mixtures may be explosive. Do not use in conjunction with soap or any anionic wetting agent. In preparing packaging mixes containing Barquat 4280-Z, use normal precautions for handling powdered materials likely to create dust. Use an exhaust fan to keep dust away from operators. Provide goggles, gloves and respirators. Under certain conditions, the use of protection creams may be advisable.

STORAGE AND DISPOSAL

- Do not contaminate water, food, or feed by storage disposal.

CONTAINER DISPOSAL
