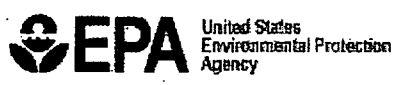

### PRECAUTIONARY STATEMENTS

#### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

**DANGER! CORROSIVE.** Causes irreversible eye damage and skin burns. May be fatal if inhaled, swallowed or absorbed through the skin. Do not get in eyes, on skin or on clothing. ### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. This product is a concentrate for formulating purposes only. This product for formulation into antimicrobial products for use in/on Agricultural premises and equipment, Food Handling/storage establishment premises and equipment, Commercial, institutional and industrial premises and equipment, Residential and public access premises, Materials and Preservatives, Medical Premises and equipment, Industrial processes and water systems, Wood preservatives, Swimming Pools and Aquatic Areas. Formulators using this product are responsible for providing data for the EPA registration of their formulated products. This product may be used to formulate products for specific use(s) not listed on this label if the formulator or primary registrant has complied with U.S. EPA data requirements regarding the support of such use(s).

**NOTE:** This product should not be used or compounded with any reducing or oxidizing agents (such as calcium hypochlorite, solid perchlorate, or nitric acid) since such mixtures may be explosive. Do not use in conjunction with soap or any anionic wetting agent.

### STORAGE AND DISPOSAL
