The following amendment submitted in connection with registration under FIFRA, as amended, is acceptable with the following conditions listed below.

- Update First Aid Statements, Precautionary Statements and Storage and Disposal Statements as required by the applicable PR Notices and the EPA Label Review Manual

**Conditions**

Revise the label as follows:

1. Based on the active ingredients in your product, we have determined that your product should be placed in the following toxicity categories.

Primary Eye	Tox I
Primary Skin	Tox I
Acute Inhalation	Tox II
Acute Oral	Tox II
Acute Dermal	Tox III
Dermal Sensitizer	Positive

If you feel this information is incorrect submit or cite data to the agency.

Thus revise the Precautionary Statements to read exactly as follows:

**Corrosive. Causes irreversible eye damage and skin burns. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield, protective clothing, and rubber gloves. May be fatal if swallowed or inhaled. Do not breathe spray mist (or vapor). Wear a dust/mist filtering respirator (MSHA/NIOSH approval number prefix TC-21C). Harmful if absorbed through the skin. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. Wash thoroughly with soap and water after handling and before eating, drinking or using tobacco. Remove contaminated clothing and wash before reuse."**

2. **Revise the "First Aid" statements by adding "If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice."**
3. **Under "First Aid," bold the subheadings, If swallowed/If in eyes/If on skin or clothing, so the statements stand out on the label.**
4. **Under the "Directions for Use," delete the use sites, "aquatic areas" and "public access premise." Your label needs to be more specific in terms of the sites which will be treated. In addition, delete the following sites which are not supported for this active ingredient: "materials and preservatives" and "antifouling coatings."**
5. **The statement which follows the product name at the top of the right column is too broad. The Agency is moving toward revising MUP labels to list the specific sites at which a product may be formulated for use, not the pesticidal claims associated with those uses. Revise the statement: "For Formulation into Antimicrobial Products" to read: "For use by manufacturers only in formulating antimicrobial products for the uses indicated on the label."**

**General Comments**

A stamped copy of the labeling accepted with conditions is enclosed. Submit three (3) copies of your final printed labeling before distributing or selling the product bearing the revised labeling.

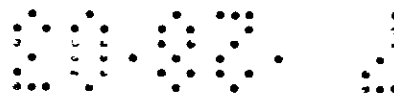
