STATEMENT OF PRACTICAL TREATMENT

For eyes and skin flush with plenty of water for at least 15 minutes. (Eyelids must be held open). Call a physician immediately. Remove contaminated clothing and wash before reuse. If swallowed, immediately give 3-4 glasses of milk; if unavailable, give water.

Do not induce vomiting. Call a physician.

DIRECTIONS FOR USE

NOTE: This product should not be used or compounded with any reducing or oxidizing agents (such as calcium hypochlorite, solid perchlorate, or nitric acid) since such mixtures may be explosive. Do not use in conjunction with soap or any anionic wetting agent.

STORAGE AND DISPOSAL

CONTAINER DISPOSAL
