**Statement of Practical Treatment**

**GENERAL CLASSIFICATION**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

**LONZA FORMULATION S-18-8** is a proven "one-step" disinfectant - cleaner - sanitizer - fungicide - mildewstat - virucide which is effective in water up to 400 ppm hardness in the presence of 5% serum contamination.

Apply **LONZA FORMULATION S-18-8** to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks, tile, porcelain, and bedframes with a cloth, mop or mechanical spray device so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

**Disinfection** - To disinfect hard non-porous surfaces, add 1 oz. per gallon of water. Treated surfaces must remain wet for 10 minutes. At this use-level **LONZA FORMULATION S-18-8** is also virucidal, fungicidal and fungistatic.

**Sanitizing** - To sanitize porous and non-porous non-food contact surfaces, add 1 oz. per 5 1/2 gallons of water. Treated surfaces must remain wet for 60 seconds.

**1 oz. per gallon use-level.** The broad spectrum activity of **LONZA FORMULATION S-18-8** has been evaluated and found to be effective against the following organisms by the AOAC Use Dilution test:

- Staphylococcus aureus
- Salmonella choleraesuis
- Escherichia coli
- Streptococcus hyogenes

**AOAC Fungicidal Test:** **LONZA FORMULATION S-18-8** is an effective fungicide against Trichophyton mentagrophytes, the athlete's foot fungus, when used on surfaces in areas such as locker rooms, dressing rooms, shower and bath areas, exercise facilities, etc.

**Mold and Mildew Control:** At 1 oz. per gallon **LONZA FORMULATION S-18-8** effectively inhibits the growth of mold and mildew and the odors caused by them, when applied to hard non-porous surfaces, as indicated in general instructions at left. Allow to dry on surface and repeat when mold begins to return.

**Virucidal Performance:** At 1 oz. per gallon use-level, **LONZA FORMULATION S-18-8** was evaluated and found to be effective against the Influenza A (Prague) Virus on a variety of non-porous surfaces.

**Sanitizing-Non-Food Contact Surfaces (such as floor, walls, tables, etc.):** At 1 oz. per 5 1/2 gallon use-level, **LONZA FORMULATION S-18-8** is an effective sanitizer against *Staphylococcus aureus* on a variety of non-porous surfaces.
