The amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable with the conditions listed below:

- Major label revisions: adding additional marketing statements, use sites, surfaces, directions for use, and organisms
- Update first aid statements per PR Notice 2001-1

General Comments

Label Comments:

- 1. Based on the acute toxicology data evaluation dated January 28, 1981, the product is toxicity category III for acute dermal. The "harmful if swallowed" statement should be revised to "harmful if swallowed and/or absorbed through the skin."
- 2. On page 3, left column 2nd paragraph, the surface, porcelain tiling, must be qualified as hard, non-porous by stating "glazed" porcelain tiling.
- 3. On page 4, under the "Disinfection/Virucidal Directions," the statement, "Do not use on utensils, glasses, or dishes, " must be added after the "rinse with potable water"

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Preparation of Disinfectant Use-Solution:

Add (mix) 2 oz. per gallon of water (1:64).

For heavy duty use, add (mix) 8 oz. per gallon of water (1:16).

Before use in federally inspected meat and poultry food processing plants and dairies, food products and packaging materials must be removed from the room or carefully protected.

DISINFECTION / VIRUCIDAL* DIRECTIONS:

Apply use-solution to hard, nonporous surfaces with a cloth, mop, sponge, sprayer or by immersion, thoroughly wetting surfaces.

For sprayer applications, use a coarse spray device. Spray 6 - 8 inches from surface; rub with brush, sponge or cloth. Avoid breathing spray.

Treated surfaces must remain wet for 10 minutes. Wipe dry with a cloth, sponge or mop or allow to air dry.

FUNGICIDAL DIRECTIONS:

For use in areas such as locker rooms, dressing rooms, shower and bath areas and exercise facilities follow disinfection directions.

LONZA FORMULATION S-21 at 2 oz. per gallon in 250 ppm hard water and 5% serum is an effective one-step fungicide against Trichophyton mentagrophytes.

LONZA FORMULATION S-21 at 2 oz. per gallon in 400 ppm hard water is an effective fungicide against Trichophyton mentagrophytes (the athlete's foot fungus) when used on pre-cleaned surfaces.

MOLD AND MILDEW CONTROL: At 2 oz. per gallon, LONZA FORMULATION S-21 will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard, nonporous surfaces. Follow disinfection instructions. Allow to air dry on surface. Repeat when mildew growth returns.

Place objects into unit and operate for a minimum of 10 minutes, according to the manufacturer's directions. Remove objects and wash with sterile water (sterile water for injection) or allow to air dry. Prepare fresh solution for each use.

DISINFECTION OF WHIRLPOOL UNITS: After using the whirlpool unit, drain, and refill with fresh water to just cover the intake valve. Add 2 oz. of Lonza Formulation S-21 for each gallon of fresh water added. Start the pump to circulate the solution. Wash down the unit sides, seat of the chair lift and any related equipment with a clean swab, brush or sponge. Treated surfaces must remain wet for 10 minutes.

TO SANITIZE BARBER / SALON INSTRUMENTS AND TOOLS: Immerse precleaned barber / salon instruments and tools (such as combs, brushes, razors, scissors, blades and manicure instruments) in a use-solution of 2 oz. of Lonza Formulation S-21 per 4 – 5 ½ gallons of water (or equivalent dilution) for at least 60 seconds (one minute). Rinse thoroughly and dry before use. Prepare a fresh solution daily or more often if solution becomes visibly diluted, cloudy or soiled.

NOTE: Plastics may remain immersed until ready to use. Stainless steel shears and instruments must be removed after 10 minutes, rinsed, dried, and kept in a clean non-contaminated receptacle. Prolonged soaking may cause damage to metal instruments.

Remove all animals and feeds from premises, vehicles, and enclosures such as coops and crates. Remove all litter, droppings and manure from floors, walls and surfaces of barns, pens, stalls, chutes and other facilities and fixtures occupied or traversed by animals. Empty all troughs, racks and other feeding and watering appliances. Thoroughly clean all surfaces with soap or detergent and rinse with water. Use 2 oz. of LONZA FORMULATION S-21 per gallon of water. Saturate surfaces with the recommended disinfecting solution for 10 minutes. Immerse all halters. ropes and other types of equipment used in handling and restraining animals, as well as forks, shovels, and scrapers used for removing letter and manure. Ventilate buildings, cars, trucks, coops and other closed spaces. Do not house animals or employ equipment until treatment has been absorbed, set or dried. This may be accomplished by using a shovel, broom, or vacuum, depending on the area to be disinfected.
