LONZA FORMULATION S-18 is a one-step disinfectant cleaner that is effective against a broad spectrum of bacteria, is virucidal\* (including HIV-1), fungicidal, and inhibits the growth of mold and mildew and their odors when used as directed.

LONZA FORMULATION S-18 is an effective one-step sanitizer-cleaner for use on non-food contact surfaces. When used as directed, LONZA FORMULATION S-18 will deodorize surfaces in toilet areas, behind and under sinks and counters, garbage cans and garbage storage areas and other places where bacterial growth can cause mal odors.

### Statement of Practical Treatment

### Directions for Use

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

LONZA FORMULATION S-18 is a proven "one-step" disinfectant-cleaner-sanitizer-fungicide-mildewstat-virucide which is effective in water up to 400 ppm hardness in the presence of 5% serum contamination.

Apply LONZA FORMULATION S-18 to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks, tile, porcelain, and bedframes with a cloth, mop or mechanical spray device so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

**Disinfection** — to disinfect hard, non-porous surfaces, add 1 oz. per gallon of water. Treated surfaces must remain wet for 10 minutes. The activity of LONZA FORMULATION S-18 has been evaluated in the presence of 5% serum and 400 ppm hard water by the AOAC use dilution test and found to be effective against a broad spectrum of gram negative and gram positive organisms as represented by:
