Use of this product will remove milkstone and scale from dairy and cheese making equipment and help maintain the efficiency of the operation as well as eliminate bacterial growth.

Use Lonza CS-201:

- as a food contact sanitizer at a concentration of 150 400 ppm active.
- as a sanitizer in bottling, pre-mix and beverage dispensing equipment.
