When used as directed, LONZA TBC-302 cleans, disinfects and deodorizes in one easy step.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Flush toilet. Add 3 fluid oz. [6 tablespoons] directly to water in toilet bowl [3/4 gallon]. Brush to cover all interior surfaces of the bowl including under the rim. Allow disinfectant solution to remain for at least 10 minutes. Flush toilet.

To clean badly stained bowls, repeat above treatment using 4 to 5 fluid ounces of LONZA TBC-302.

For use in urinals, add 3 fluid oz. [6 tablespoons] to 3/4 gallon of water. Apply by brush to all urinal surfaces. Allow disinfectant solution to remain at least 10 minutes. Flush.
