The amendment submitted in connection with registration under FIFRA section 3(c)(7)(A) is acceptable with the conditions listed below.

Response to Agency letter dated August 20, 2004

# **Conditions**

Revise the label as follows:

- Page 1: This product is category I for primary skin irritation. Under "Precautionary 1. Statements," the 3rd sentence must be revised to include "protective clothing."
- Page 1: Under "First Aid," Bold the subheadings, "IF IN EYES, IF ON SKIN OR 2. CLOTHING, and "IF SWALLOWED."
- Page 2: Under "Where to Use": The Agency classifies microwave ovens and refrigerators 3. as food contact surfaces. We are particularly concerned about the use of this product in residential setting where we believe that the user will not conduct a potable water rinse on interior surfaces of refrigerators. If you desire that all surfaces of refrigerators and microwave ovens be treated in a commercial setting and are willing to limit the use on these surfaces by homeowners, you must revise the label by stating microwave oven exteriors, refrigerator exteriors, commercial/institutional microwave ovens and refrigerators..

It is suggested that this label have separate surfaces and directions for use in commercial settings and residential settings. These directions would continue to indicate the necessity


- 4. Page 2: Under "Where to Use," specify that the picnic tables and Outdoor (patio) furniture are hard nonporous surfaces by stating Non-wooden picnic tables and "Outdoor (patio) furniture except cushions and wood frames
- 5. Page 4: Revise the "Virucidal" directions by adding "Use a 30 minute contact time against Foot and Mouth Disease. Allow surfaces to air dry."
- 6. Page 4: Under "HIV-1" directions, the shaded revision must read "on" not "of." Also, revise the "contact time" by adding the statement, *Use a 30 minute contact time against Foot and Mouth Disease.*"
- 7. Page 4: Under "Toilet Bowl/Urinal" add the statement, "Remove gross filth prior to disinfection." Also, revise the 2<sup>nd</sup> sentence "From concentrate" section to read "Thoroughly brush or swab over exposed surfaces and under the rim with a cloth, mop, brush, or sponge. Allow to stand 10 minutes and flush."
- 8. Since this product may be used to clean and disinfect various vehicles, you must add the following directions to the label:
  - Vehicles: Clean all vehicles including mats, crates, cabs, and wheels with high pressure water and Lonza DC-101. Use 3 oz. per gallon of water to treat all hard non-porous surfaces. Leave treated surfaces wet for 10 minutes, allow to air dry.
- 9. Since this product may be used in food processing plants and food storage areas, the following directions must be added:
  - Food Processing Plants and Storage Areas: Before disinfecting hard, non-porous surface, food products and packaging materials mut be removed from the room or carefully protected. Follow disinfection directions.


