

TO CLEAN, SANITIZE AND DEODORIZE CARPETS:

STEAM EXTRACTION: Vacuum carpet thoroughly. Mix two (2) ounces of LONZA CARPET SANITIZER CS-202 per gallon of water. Inject and extract as you would any steam cleaning shampoo.

EXTRACTION: Vacuum carpet thoroughly. Mix two (2) ounces of LONZA CARPET SANITIZER CS-202 per gallon of water. Prespray onto the carpet at a rate of 1/3 – 1/2 gallon per 100 square feet and extract as you would other extract cleaning shampoos.

<u>SPIN BONNET (BONNET BUFF) CLEANING</u>: Vacuum carpet thoroughly. Mix four (4) ounces of LONZA CARPET SANITIZER CS-202 per gallon of water. Bonnet on carpet at rate of 200 - 300 sq. ft. per gallon.
