The following amendment submitted in connection with registration under FIFRA, as amended, is acceptable with the conditions listed below.

Update First Aid Statements per PR Notice 2001-1

Conditions

Revise the label as follows:

1. Page 1: Revise the "Precautionary Statements" by adding the phrase, "protective clothing" to the 4th statement and the statement, "Remove contaminated clothing and wash before reuse. Wash thoroughly with soap and water after handling." Also, delete the statement, "Avoid contamination of food."

Page 2: Directions for Use Revisions

- Qualify the surface, tile, as hard nonporous by stating "glazed" tile. (Located left panel 2nd paragraph)
- 3. Revise the "Disinfection" directions by adding the statement, "Allow surfaces to air dry."

 It must appear after the contact time.
- 4. Under "Fungicidal Performance, add the statement, "Follow disinfection directions."
- 5. Page 5: Revise the "Sanitizing Food Contact Surfaces" Directions by deleting the statement, "For heavily soiled ... S-37F," and replace it with "Prior to application, remove gross food particles and soil by a pre-flush or pre-scraped and when pages in the statement of the st

LONZA FORMULATION S-37F is a one-step disinfectant cleaner that is effective against a broad spectrum of bacteria, is virucidal, fungicidal, and inhibits the growth of mold and mildew and their odors when used as directed.

LONZA FORMULATION S-37F is an effective one-step sanitizer cleaner for use on food contact, as well as non-food contact surfaces.

When used as directed, LONZA FORMULATION S-37F will deodorize surfaces in toilet areas, behind and under sinks and counters, garbage cans and garbage storage areas, and other places where bacterial growth can cause mal odors.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

LONZA FORMULATION S-37F is a proven one-step cleaner – disinfectant – sanitizer – fungicide – mildewstat - virucide in the presence of moderate amounts of organic soil.

Apply LONZA FORMULATION S-37F to walls, floors and other hard nonporous surfaces such as tables, chairs, countertops, sinks, tile, glazed porcelain with a cloth, mop or mechanical spray device so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or more often if the use solution becomes visibly dirty.

Rinse all surfaces that come in contact with food such as countertops, appliances, tables and stovetops with potable water before reuse. Do not use on utensils, glassware and dishes as a disinfectant.


VIRUCIDAL PERFORMANCE: At 1 oz. per gailon uselevel LONZA FORMULATION S-37F was evaluated in the presence of 5% serum found to be effective against the following viruses found on hard, nonporous, surfaces:

FUNGICIDAL PERFORMANCE:

LONZA FORMULATION S-37F is an effective fungicide against Trichophyton mentagrophytes (the athlete's foot fungus) when used on surfaces in areas such as locker rooms, dressing rooms, shower and bath areas, exercise facilities at 1 oz. per gallon.

MOLD AND MILDEW CONTROL: At 1 oz per gallon, LONZA FORMULATION S-37F will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard, non-porous surfaces (as indicated in general instructions above). Allow to dry on surface and repeat when mildew growth returns.



(Note for reviewer: For labels that list medical premises and metal and/ or stainless steel surfaces, one of the following statements must be used:)

This product is not to be used as a terminal sterilant / high level disinfectant on any surface or instrument that (1) is introduced directly into the human body, either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. SANITIZING FOOD CONTACT SURFACES: At 1 oz. per 31/2 gallons water use LONZA FORMULATION S-37F for sanitizing and cleaning of equipment and utensils in food processing, dairy industry, bars, restaurants, institutional kitchens, meat and poultry processing plants and farms. Do not rinse with water. For heavily soiled equipment or utensils, pre-wash with LONZA FORMULATION S-37F. Rinse with clean water, then apply recommended dilution of LONZA FORMULATION S-37F with a cloth, mechanical spray device (spray surface until thoroughly wetted) or immersion. Treated surfaces must remain wet for one minute. Prepare a fresh solution for every use. DO NOT reuse mechanically applied use solution for sanitizing. - 1. Thoroughly wash equipment and utensils in a hot detergent solution.
- 2. Rinse utensils and equipment thoroughly with clean water.
- Sanitize equipment and utensils by immersion in a 1 oz. Per 3 1/2 gallon solution of LONZA FORMULATION S-37F (150 ppm active) for at least 60 seconds at a temperature of 75° F.

(If container size is greater than gallon, the following storage and disposal statements will be used:)
