

- C. On page 2, right panel in the fourth section revise as follows: "Lonza Formulation R-82-F for use in hospitals, homes..." Also delete the following two sites which are too broad: "institutional facilities" and "public facilities."
- D. On page 2, right panel in the fifth section revise as follows: "Lonza Formulation R-82F for use on the following washable hard nonporous surfaces: floors..." deleting the word "including" and revise the statement "...heat pumps, conductive flooring and hard nonporous surfaces made of metal..." deleting the word "other."
- E. On page 4, left panel in the third section revise as follows: move the statements beginning "For sprayer applications, use a ..." and ending "Avoid breathing spray." to immediately follow the statement in the fourth section ending "...thoroughly wetting surfaces with a cloth, mop, sponge or sprayer." Revise the final statement of this section to read "...solution becomes visibly soiled or diluted."

- F. On page 4, left panel in the section for use as a toilet bowl cleaner, place the following statement at the beginning of this section "Remove gross filth prior to disinfection."
- G. On page 4, right panel in the first section revise as follows: "...per quart of water) to disinfect hard nonporous instruments..."
- H. On page 5, left panel in the U.S. Public Health Service Food Service Sanitization Recommendations section delete the last statement "Wash thoroughly with soap and water after handling." This statement seems contradictory to the previous statement which instructs the user to let the surfaces which have been sanitized air dry. The users are already advised in the Precautionary Statements to wash (hands) thoroughly with soap and water after handling the product.
- I. On page 5, right panel in the first section revise as follows: "Ventilate buildings, cars, trucks, coops and ..."
- J. On page 5, right panel in the second section revise as follows: "...per gallon of water to treat the following hard nonporous surfaces: hatchers, setters..." Add the following statement to the end of this section: "Then allow to air dry."
- K. On page 6 in the first section revise as follows: "For cleaning and disinfecting the following hard nonporous surfaces: equipment not used for animal food or water, utensils..." deleting the word "including."

CLEANING AND SANITIZING: Equipment and utensils shall be thoroughly pre-flushed or pre-scraped and when necessary, pre-soaked to remove gross food particles and soil.

- Thoroughly wash equipment and utensils in hot detergent solution.
- 2 Rinse utensils and equipment thoroughly with clean water.
- Sanitize equipment and utensils by immersion in a ½ oz. per 4 5 ½ gallon solution of Lonza Formulation R-82F (200 150 ppm active) for at least 60 seconds at a temperature of 75°F.
- 4. For equipment and utensils too large to sanitize by immersion, apply a ½ oz. per 4 5 ½ gallon solution of Lonza Formulation R-82F (200 150 ppm active) by rinsing, spraying or swabbing until thoroughly wetted.
- Allow sanitized surface to drain and air dry. Do not rinse

Wash thoroughly with soap and water after handling.

# Poultry and Swine Premise Disinfection Directions:

Remove all animals and feeds from premises, vehicles, and enclosures such as coops and crates. Remove all litter, droppings and manure from floors, walls and surfaces of barns, pens, stalls, chutes and other facilities and fixtures occupied or traversed by animals. Empty all troughs, racks and other feeding and watering appliances. Thoroughly clean all surfaces with soap or detergent and rinse with water. Use 1/2 oz. of LONZA FORMULATION R-82F per gallon of water. Saturate surfaces with the recommended disinfecting solution for 10 minutes. Immerse all halters, ropes and other types of equipment used in handling and restraining animals. as well as forks, shovels, and scrapers used for removing letter and manure. Ventilate buildings, coops and other closed spaces. Do not house animals or employ equipment until treatment has been absorbed, set or dried. Thoroughly scrub treated feed racks. mangers, troughs, automatic feeders, fountains and waterers with soap or detergent, and rinse with potable water before reuse.

Hatcheries: Use ½ oz. of LONZA FORMULATION R-82F per gallon of water to treat hatchers, setters, trays, racks, carts, sexing tables, delivery trucks and other hard surfaces. Leave all treated surfaces wet for 10 minutes or more.

Vehicles: Clean all vehicles including mats, crates, cabs and wheels with high pressure water and LONZA FORMULATION R-82F. Use ½ oz. of LONZA FORMULATION R-82F per gallon of water to treat all vehicles. Leave all treated surfaces wet for 10 minutes or more.

Shoe Bath Sanitizer Directions: To prevent tracking harmful organisms into animal areas, shoe baths containing one inch of freshly made solution should be placed at all entrances to buildings and hatcheries. Disinfect offal rooms, exterior walls and loading platforms of dressing plants. Cover or remove all food and packaging materials. Remove all heavy soils prior to application. Saturate all surfaces with a ½ oz. per gallon of water solution. Scrub to loosen all soils. Surfaces must remain wet for 10 minutes, then thoroughly rinsed with potable water before operations are resumed.

Veterinary Practice / Animal Care / Animal Laboratory / Zoos / Pet Shop / Kennels Disinfection Directions: For cleaning and disinfecting hard nonporous surfaces including equipment, utensils, instruments, cages, kennels, stables, catteries, etc. Remove all animals and feeds from premises, animal transportation vehicles, crates, etc. Remove all litter, droppings and manure from floors, walls and surfaces of facilities occupied or traversed by animals. Thoroughly clean all surfaces with soap or detergent and rinse with water. Saturate surfaces with a use-solution of ½ oz. of LONZA FORMULATION R-82F per gallon of water (or equivalent dilution) for a period of 10 minutes. Ventilate buildings and other closed spaces. Do not house animals or employ equipment until treatment has been absorbed, set or dried.

### Farm Premise Use:

Do not use in milking stalls, milking parlors or milk houses. Remove all animals and feed from premises, vehicles and enclosures. Remove all litter and manure from floors, walls and surfaces of barns, pens, stalls, chutes and other facilities and fixtures occupied or traversed by animals. Empty all troughs, racks

\other feeding and watering appliances. Thoroughly clean all surfaces with soap or detergent and rinse with water. Saturate all surfaces with a use-solution of ½ oz. of LONZA FORMULATION R-82F per gallon of water (or equivalent dilution) for a period of 10 minutes. Immerse all halters, ropes and other types of equipment used in handling and restraining animals as well as forks, shovels and scrapers used for removing litter and manure. Ventilate buildings, cars, boats and other closed spaces. Do not house livestock or employ equipment until treatment has been absorbed, set or dried. Thoroughly scrub all treated feed racks, mangers, troughs, automatic feeders, fountains and waterers with soap or detergent, and rinse with potable water before reuse.
