Dear Ms. Holcombe,

The following amendment submitted in connection with registration under FIFRA, as amended, is acceptable with the conditions listed below.

Proposed Amendment

- Update Storage and Disposal per PRN 2007-4
- Update Company Address and add optional statements

Conditions

Revise the label as follows:

1) The Environmental Hazards on page 2 must be revised to be in agreement with the ADBAC and DDAC REDs by adding the statement, "*This pesticide is toxic to fish and aquatic invertebrates*."

2) The nomenclature for Avian Influenza (H3N2) and (H5N1) Influenza Type A/Brazil, and Vaccinia is incomplete on pages 5, 13 and 19. You need to indicate that the microorganisms are viruses by stating "Avian Influenza *Virus* (H3N2) and (H5N1), Influenza *Virus* Type A/Brazil and Vaccinia *Virus*."

3) The Container Rule rescinded PR Notice 83-3 and 84-1 Part II in which Container Disposal statements are no longer separated by container size but by use pattern. Therefore, delete the "Storage and Disposal" statements for containers one gallon or less with uses other than household/residential. Revise the first "Note to reviewer" to state "For Nonrefillable containers

for household/residential uses" and the the for the residence of the state "For Nonrefillable symbol containers for institutional industrial/commercial uses."

7) Revise the "Container Disposal" statements for the institutional/industrial/commercial uses to read:

Container Disposal: Nonrefillable container. Do not reuse or refill container. Clean container promptly after emptying.

(Containers 5 gallons or less [please note that the statements are the same for plastic and metal containers])

Triple rinse as follows: Fill container ¹/₄ full with water and recap. Agitate vigorously. Follow Pesticide Disposal instructions for rinsate disposal. Drain for 10 seconds after the flow begins to drip. Repeat procedure two more times. Then offer for recycling or reconditioning. If not available, puncture and dispose in a sanitary landfill.

(Container greater than 5 gallons [please note that the statements are the same for plastic and metal containers])

Triple rinse as follows: Fill container ¹/₄ full with water. Tip container on its side and roll it back and forth, ensuring at least one complete revolution for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into the application equipment or mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling or reconditioning. If not available, puncture and dispose in a sanitary landfill.

(For Bag in Box Containers): Proposed language acceptable.



Regular, effective cleaning and sanitizing of equipment, utensils, and work or dining surfaces which could harbor food poisoning microorganisms minimizes the probability of contaminating food during preparation, storage or service. Effective cleaning will remove soil and prevent the accumulation of food residues, which may decompose or support the rapid development of food poisoning organisms or toxins. Application of effective sanitizing procedures reduces the number of those organisms which may be present on equipment and utensils after cleaning, and reduces the potential for the transfer, either directly through tableware such as glasses, cups and flatware or indirectly through food.

To prevent cross-contamination, kitchenware and food-contact surfaces of equipment must be washed, rinsed with potable water and sanitized after each use and following any interruption of operation during which time contamination may have occurred.

Where equipment and utensils are used for the preparation of foods on a continuous or production-line basis, utensils and the food-contact surfaces of equipment must be washed, rinsed with potable water and sanitized at intervals throughout the day on a schedule based on food temperature, type of food, and amount of food particle accumulation.

Articles that can be immersed in solution must remain in solution for 60 seconds.

Articles or surfaces too large for immersing must be thoroughly wetted or flooded by rinsing, spraying or swabbing.

Allow all sanitized surfaces to drain thoroughly [and air dry].
