Delete the term Sanitizer' (two instances) from the FOGGING DEVICE HATCHERY ROOM SANITIZER DIRECTIONS and FOGGING DEVICE INCUBATOR AND HATCHER SANITIZER DIRECTIONS section on page 20 The Agency has not approved a method to support a sanitizing claim associated with fogging

Lonza stated its intention to comply with this request in the cover letter of the 3-13-2012 submission but inadvertently did not remove the language on the label—which later became the 4-11-2012 EPA stamped label—The purpose of this notification is to correct that oversight
